### NOTICE OF PUBLIC HEARING (PROTEST HEARING)

**NOTICE IS HEREBY GIVEN** that a Protest Hearing will be held by the Executive Officer of the Ventura Local Agency Formation Commission (LAFCo) for the following matter, and that all interested persons are invited to be present and heard: **LAFCo 17-08 Ventura County Fire Protection District Annexation – Santa Paula.**

**Project Description:** The Ventura County Fire Protection District (VCFPD) and City of Santa Paula (City) propose to annex the entirety of the City to the VCFPD in order for the VCFPD to provide fire protection services to the territory within the City.

**Purpose of the Protest Hearing:** The Ventura LAFCo adopted resolution LAFCo 17-08 making determinations and approving the subject proposal on January 17, 2018, subject to conducting authority proceedings (known as protest proceedings), as required by Government Code § 57000 et seq. Pursuant to Government Code § 57026(g), any owner of land within the City, or any registered voter residing within the City, may file a written protest against the proposal with the Ventura LAFCo Executive Officer at any time prior to the conclusion of the Protest Hearing. Not more than 30 days after the conclusion of the Protest Hearing, the Executive Officer shall make a finding regarding the value of written protests, and depending on their value, shall (1) terminate proceedings, (2) order the annexation subject to confirmation by registered voters residing within the City, or (3) order the annexation (Government Code § 57075). Written protests must comply with Government Code § 57051. Written protest forms are available on the Ventura LAFCo website ([www.ventura.lafco.ca.gov](http://www.ventura.lafco.ca.gov)) by clicking on the “Documents & Links” tab or at the LAFCo office, 800 S.
